## SELECTMEN'S MEETING MINUTES

# January 13, 2015

**Item 1. Call to Order.** The meeting was called to order at 6:32 PM. Selectmen present were Tom Carone (TC), William Rowe (WR), and Melissa Randall (MR). Deputy Town Clerk Dorene Foss took minutes. ## Item 2. Pledge of Allegiance

#### Item 13. Executive Session. Moved up by Select Board

- A. WR moved to go into executive session to discuss a personnel matter under 1 MRSA 405 (6)
  A. This was seconded by TC and the Board went into executive session with at 6:38 P.M.
  The Board came out of executive session at 6:55 pm.
- B. WR made a motion to accept Mr. Wood bury as the new Sangerville Town Manager effective Tuesday January 20th. TC seconded, motion passed 3-0
- C. MR made a motion to pay Mr. Woodbury \$45,000 annual salary starting 1/20/2015. With a satisfactory review after 6 months there will be an increase of \$2500. There will be another review after one year and a possible increase if satisfactory. WR seconded, motion passed 3-0

- A. Add the discussion of the contingency fund under old business.
- B. Talk about mowing bid. MR made a motion to table the discussion about the mowing bids until the Jan 22, 2015 meeting. WR seconded, motion passed 3-0

Phil Martin wanted to point out that the front hall section of the town hall, were all of his maintenance tools and supplies are kept has a sink with running water. He is concerned that with the cold temperatures lately there is a possibility of those pipes freezing. He is suggesting that a heater of some type be purchased to help prevent that from happening. Tom made a suggestion to get one of those small inexpensive heaters to use in the front area.

TC made a motion to accept the high bid for Map 5 Lot 34-1, the Brockway Mills property made by Mark Dyer & Lynn Davis for \$2,501. WR seconded, motion passed 3-0

TC made a motion to accept the high bid for Map 19 Lot 5, the Double wide property made by Amos & Bonnie Lawrence for \$5,250. MR seconded, motion passed 3-0

**B.** WR made a motion to send the COTE Ordinance to Eaton & Peabody for review. MR seconded, motion passed 3-0

## Item 8. New Business.

- A. The following 3 tax acquired properties need to be advertised. Map 5 Lot 45, Map 2 Lot 3 and Map 1 Lot 4. MR made a motion to advertise the 3 properties in the Observer for 2 weeks with the bid closing to be 5 pm on Feb 10<sup>th</sup>. Bids to be opened that night at the Selectboard Meeting. - **B.** Patterson's sent in a 2015 contract in the amount of \$550 for waste removal. WR made a motion to accept the contract, TC seconded, motion passed 3-0.
- C. Hamlin Associates sent in a 2015 contract in the amount of \$15,300 for April 1, 2015 thru March 31, 2016. MR made a motion to accept the contract as written. WR seconded, motion passed 3-0
- **D.** WR made a motion to take up to \$1500 from the contingency to pay for a new computer for the town manager, to include Microsoft 2013 to all 3 office computers and cover the installation. TC seconded, motion passed 3-0
- **E.** Letters are to go out to the Budget Committee announcing their first meeting to be held on January 28<sup>th</sup>, 2015. TC made a motion for the selectboard to have a budget workshop on 1/21/15 at 10am with no public comments, WR seconded, motion passed 3-0.
