EMHS DISCUSSION

- ! Why talking to EMHS? To achieve our Mission.
- ! Mayo has been operating at a loss for the past several years.
- ! Mayo's Board recognizes that in order to retain clinical services, we will need to find a partner with a larger organization for assistance in reducing other expenses.
- ! A larger partner will also enable us to continue to invest as we have been, as cash flows become tighter. (I.e. Infrastructure, Oncology, new equipment etc.).
- ! We are currently operating under an Interim agreement.
- ! Mayo's Board has spent the last year working with EMHS and getting education from them about their organization.
- ! We are identifying areas we can collaborate to improve.
- ! A much closer working relationship would be created with CA Dean.
- ! Another agreement will be proposed to begin January2018. This agreement will establish timelines for community education and further discussion during the coming year.

Notes: Gross Revenue rebounded over the past four months to end 2017 1.6% under budget but 2.5% above 2016. Expenses were slightly under budget and 1.5% higher than 2016. While volumes have been higher recently, we remain in a relatively high risk environment for continued volume levels, provider staffing, wage pressures, and payment pressures.
