Item 1. Open Meeting: (Pledge). Chairman Mike Wark called meeting to order at 5:01 PM, followed by the Pledge of Allegiance.

Item 2. Executive Session.

A. 1 MRSA 405 (6) A – Irving McNaughton, Road Committee Member.

Chairman Wark made a motion and Selectman Cabot 2nd to table the executive session until the weather is cooler. All in favor.

Item 3. Approval of Minutes: None.

Item 4. Review of the Treasurer's Warrants:

- A. Payroll #87, 88, 92.
- B. Accounts Payable #86, 89, 90, 91.

Selectman Gray made a motion and Selectman Cabot 2nd to approve all warrants. All in favor.

Item 5. Open Session: Limited to 2 Minutes – Extension per Chairman.

Warren Nuite: Mr. Nuite was present to voice some concerns. Due to the nature of his concerns, Chairman Wark made a motion and Selectman Cabot 2nd to move to executive session under 1 MRSA 405 (6) A, personnel matters with Warren Nuite at 5:07PM. All in favor.

Chairman Wark made a motion and Selectman Gray 2nd to come out of executive session at 5:43 PM. All in favor. No action taken.

Item 6: Selectmen Concerns:

- A. Selectman Cabot. Selectman Cabot mentioned she had stopped at the Town Garage when Jason K was there. She had a concern that he was using the facility a little too freely. He did show her around the Garage and show her what equipment, etc, was there.
- **B.** Selectman Gray. Selectman Gray informed that he had been at the Center Pond public landing and that the dock is in disrepair, as well as the concrete ramp in the water may need some adjusting. It was mentioned to contact the Department of Conservation so determine if they have any assistance available to Towns to repair public boat landings.

Item 7. Committee Reports:

A. Rec Committee.

- 1. **Director Resignation.** Selectman Cabot made a motion and Selectman Gray 2nd to accept the resignation of James Bell as the Recreation Director. All in favor.
- 2. Joe Riitano, Sr. After research with MMA Legal, it was determined that a Town vote of the legislative body would be required to name a part of the field.
- 3. The Board asked if they could have a special meeting with the Rec Committee and Pirate Rec some time in the near future. Manager will contact Jason to confirm date and time.
- **B. Road Commissioner.** Pike is preparing to pave the 1.1 miles of Silver's Mills Road. The gravel section near Hartford Lane will need to be graded prior to paving. Board directed to have it done to Pike's wishes, as we want the best, longest-lasting job we can get.

Selectman Gray made a motion and Selectman Cabot 2nd to allow Tobey Cleaves to cut the trees in the Town right-of-way on the south side of the Gray Road that abuts his property after Lentini's driveway, to just beyond the section where the easement will be built on Mr. Burgess's property. It was also moved to grant him permission to skid the trees down the road to the Dave Cleaves field entrance. All in favor.

Chairman Wark asked about the possibility of the Town's liability, due to the guardrails on the French's Mill Road that need repair. Manager will inquire with MMA Legal.

Item 8. New Business:

A. Contingency Expense. Chairman Wark made a motion and Selectman Gray 2nd to go into executive session under 1 MRSA 405 (6) A for the purpose of discussing a personnel issue, at 6:30 PM. All in favor.

Chairman Wark made a motion and Selectman Cabot 2nd to come out of executive session at 6:52PM. All in favor.

Selectman Gray made a motion and Selectman Cabot 2nd to approve the sum of \$3,000 to settle a pending workers' compensation claim, paid from Contingency, on warrant #93. All in favor.

- **A. Abbie Fowler/Brian Howard proposal update.** Mr. Nessmann, the attorney Mr. Howard is using for his proposal for purchase of Abbie Fowler, is the attorney we are using for the easement deed for the turnaround Mr. Burgess offered the Town. He provided the Town with a multiple employment disclosure for the Board to acknowledge and agree to continue to use Mr. Nessmann for the Easement Deed. Signed.
