- A. **Guardrail.** The guardrail for French's Mill Road has been a priority to be repaired/replaced. Gordon Contracting submitted a price for \$52/foot. CA Newcomb submitted \$30/ft, and Seth had contacted a third vendor that submitted a price of around \$23/foot, but it did not include endcaps, so the price would most likely be more than the \$30/foot price. Selectman Cabot made a motion and Selectman Gray 2nd to accept the bid of CA Newcomb for \$21,250. All in favor. The guardrails will be installed on Monday, September 17th. Seth has already prepped the guardrail areas.

Item 3. Old Business.





