MMA recommend a non-appropriation clause be added to the contract if the Town went with a multi year contract. The Board also wanted the Edgerly Boat Landing Road added to the list for brush cutting.

**C. Town Report-**The Town Report is coming along. A decision needs to be made on who to dedicate the report to. In order to pull together information for Town Meeting on the Town Hall foundational issues, Town Meeting needs to be moved back into March.
