The State of Maine DOT contacted the Town Manager regarding upcoming work on Route 23.

Item 11. Selectmen Concerns: Selectman Cabot received a phone call with some concerns including the transfer station, town meeting and the invocation read during town meetings.

Several incidents in Sangerville occurred over the weekend. A person kayaking on Center Pond flipped their boat and was rescued by a neighboring camp owner. The kayaker's family member swam out in the water to assist. The family member was also rescued by the camp owner.

During this incident 911 was called; Sangerville, Dover Rescue and Inland Fisheries arrived to assist. Life Flight was called in a separate incident involving an ATV.

The dock for Center Pond is ready to be put in. The Town Manager is looking for assistance to get the dock in on Manhanock.

A caller reported a dead deer on the beach. The Town Manager contacted Inland Fisheries, who has removed the deer.
