A. Code Enforcement Officer & LPI Appointment & Retirement

B. CEO-Interested Parties

Kevin Sipple and Mark McNaughton attended the Select Board Meeting with interest in the position for Code Enforcement Officer. The Select Board and Town Manager discussed the position as CEO, pay, training requirements and licenses.

D. E 911 Addressing

The Town Manager/Road Commissioner has been working on several requests for addresses. Some discrepancies with the E 911 system have been found and are being corrected. An address on Kittridge Hill is listed as McNaughton Hill Rd. An address is listed on Brockway Mills that is off Ames Lane.

Item 7. Abatements and Supplements

A. Abatement

Abatement of \$222.11 in 2021 property taxes, Map & Lot 014-03, as requested by Joshua Morin, Assessors' Agent, because the camp had been reported as burned in 2020, but not removed from taxes. Selectman Cabot made a motion to make an abatement of \$222.11 on map & lot 014-003 and it's been suggested that we do that by our assessors' agent because the camp was burned in 2020, Selectman Gray 2nd. All in favor.

Item 8. Town Manager Report: Heat Pump in Library repaired

The Library's heat pump fan motor has been repaired.

Item 9. Road Commissioner: East Sangerville Rd, Patch, Beaver Trapped, Anderson Rd, ATV Trail, Manhanock Dam

Culverts are going to start tomorrow. There is no date when the patch will start, the Road Commissioner will check back in with Herricks. The Road Commissioner hired Josh Cates to take care of the beavers on Silvers Mills Rd. Two beavers have been trapped, Josh believe the problem has been taken care of. Herricks looked at the two culverts on Anderson Rd. Someone has been messing with the Manhanock Dam again. There was a request to fill the ATV trail on McPhetres Rd, as the paving from last year has left a drop off. Boat Landing Rd needs to be graded; Herricks can't do it for two weeks, the Road Commissioner will reach out to a couple other people to see if they can do it any sooner.

Item10. Correspondence: The Town Manager received a letter from CMP regarding a permit for a pole on the corner of Flanders Hill and Lanes Corner Rd.
