# A. John Shea from PCEDC to Talk About Broadband

PCEDC applied for a grant with ConnectME to do broadband inventory and gap analysis for Piscataquis County. John Shea met with the Select Board to discuss the grant. Selectman Gray played a recorded message from Bill Varney of Premium Choice Broadband further explaining the project.

**C&W Nuite-** Plow Contract needs to be finalized. The Town Manager will be updating the verbiage in the contract. Discussed the cost difference if C&W will be using their own loader in the event the town sells this equipment.

## B. ARPA Money

Signing up for the ARPA money is requiring the bank account number for the funds to be deposited. MMA has approved the site.

### C. Code Enforcement Officer Search

Al Tempesta and Lance Johnson have expressed interest in the CEO position.

#### D. Town Planters

The Town Manager has found someone to work on cleaning up the planters. The planters are currently in rough shape.

## E. GA Ordinance Hearing

The Town Manager has sent the Select Board Property Maintenance Ordinances from other towns. Property Maintenance Ordinance will need to be enforceable. Many complaints have come in about a particular property.

Patches were applied to Goff Rd, Silvers Mills Rd, Flanders Hill Rd. The Road Commissioner received an estimate from Herricks about putting culverts down on Anderson Rd. The Road Commissioner is expecting an estimate from Brian Howard for the Manhanock Dam.

The in person training classes scheduled October 12 have been cancelled due to COVID. The office will remain open. Rebecca Packard is no longer on the School Board. Sangerville has four School Board seats; currently two seats are filled and two are vacant.

Lee Lorigan would like to put parking spots in front of the their business in town. The Town Manager is awaiting a response from DOT.
