Item 1. Open Meeting: Chairman Wark called meeting to order at 4:05 pm, followed by the Pledge of Allegiance.

Item 2. Approval of Minutes:

- A. Select Board Meeting: 03/16/2022
- B. Annual Town Meeting: 03/17/2022

Selectman Cabot made a motion to approve A & B, Chairman Wark 2nd. All in favor.

Item 3. Review of the Treasurer's Warrants:

Selectman Cabot made a motion to approve A & B as read, Chairman Wark 2nd. All in favor.

Item 4. Open Session: Limited to 2 Minutes – Extension per Chairman: Toby Hall inquired if there have been any updates for the Forest Committee and discussed the Forestry Management Plan. No members have been appointed in quite a while. The Select Board will look into it.

Chairman Wark made a motion to table assessor's contract, plow contract and assessor's agent contract (Items 6A-6C) to discuss at a later time with Selectman Gray. Selectman Cabot 2nd.

D. Donation

A \$100.00 donation for the Veteran's Memorial Park was received in honor of Ed Grant. Donation accepted.

E. School Board

Selectman Cabot made a motion to appoint Jesse Soden to the school board for a 3-year term expiration 2025, Chairman Wark 2nd. All in favor.

F. Oaths for Animal Control and Planning Board

Selectmen signed the oaths for Gary Sudsbury-Animal Control Officer, Gerald Jackson-Planning Board and Gerald Peters- Planning Board; terms expiring at the Annual Town Meeting in 2023.

Item 7. Town Manager Report:

A. 2021 Taxes Liens to be filed on April 13, 2022

30 day lien notices expired on April 4th. Tax liens will be filed on April 13th, 2022.

B. ARPA

An ARPA training is scheduled for April 13th instructing how the plans to spend the funds are submitted. Plans for ARPA funds are required to be entered in the database by the end of April.

Item 8. Road Commissioner Report:

A. Gravel Roads – Line, West, Townhouse and Thomas

West Road has received some crushed rock. Contractor has been working to smooth out Line Road, Thomas Road and Townhouse Road. Quotes to have the roads graded twice this year planned.

B. Street Signs

A few roads are missing street signs, road commissioner has ordered the needed signs. Replacement signs are anticipated to be up by May.

Chairman Wark made a motion for Executive Session under 1 MRSA 405 (6)A Personnel at 5:30 pm, Selectman Cabot 2nd. At 5:45 pm Chairman Wark made a motion that we come out of executive session, Selectman Cabot 2nd. Action taken. Chairman Wark made a motion effective immediately the Town Manager, Lorna Bell will be placed on paid administrative leave while the town's attorney conducts an internal investigation, Selectman Cabot 2nd.

Chairman Wark and Selectman Cabot vote to confirm the motion.


Adjourn. Chairman Wark made a motion that we adjourn at 5:47 pm, Selectman Cabot 2nd. All in favor.




