

**TOWN OF SANGERVILLE

MEETING MINUTES

Wednesday, May 18, 2022**

**Item 1. Open Meeting:** Chair called meeting to order at 4:00 pm, followed by the Pledge of Allegiance.

- A. Selectpersons Present: Mike Wark, Dale Gray, Jody Cabot
- B. Employees Present: Lorna Bell
- C. Public Present: Chris Nuite (C&W Nuite)

**Item 2. Approval of Minutes:**

- A. **Select Board Meeting: 05/04/2022**

Selectperson Cabot made a motion to approve, Selectperson Gray 2<sup>nd</sup>. All in favor.

**Item 3. Review of the Treasurer's Warrants:**

- A. **Payroll - #39, #41**
- B. **Accounts Payable - #40, #42**

Selectperson Gray made a motion to approve A & B as read, Selectperson Cabot 2<sup>nd</sup>. All in favor.

**Item 4. Open Session: Limited to 2 Minutes – Extension per Chairman: None**

**Item 5. Old Business:** Some culverts put in last year on Silvers Mills Road need replacing. The contractor who completed the culverts shared his opinion with the Town Manager, that the culverts current conditions are a result of not having the road trench paved. The Select Board inquired to Chris Nuite what culverts need replacing- Culverts #7, #8 & #9 at least. The Select Board discussed possibly raising the road to eliminate some culverts. Work needs to start as soon as possible so paving can be completed, grind the road and gravel from Route 23 to Brockway Mills.

**Item 6. New Business:**

- A. **Notice of Election RSU 80/MSAD #4 Budget Validation Referendum – Select Board's Signatures**

Select Board signed the Notice of Election.

- B. **Cemetery Deed – Colleen and Dennis Fournier, Bailey's Cemetery**

Selectperson Cabot made a motion that we will sell two plots in the Bailey Cemetery Row 3, Plots 31 and 32 (Lot A, B, C, D) to Dennis and Colleen Fournier, Selectperson Gray 2<sup>nd</sup>. All in favor.

- C. **Public Restrooms**

Due to the closure of the library and the employees now cleaning the office, the Select Board agreed that the public restrooms will remain closed. The Veteran's Memorial Park has a restroom available to the public.

**Item 7. Town Manager Report:**

- A. **Absentee Ballots for State of Maine Primary Election/MSAD #4 School Budget on June 14, 2022 are now available**

Absentee Ballots are available. The Town of Sangerville now has a secured absentee drop box.

**Item 8. Road Commissioner Report:**

- A. **Grading**

C&W Nuite has started grading the roads.

- B. **In-Town Road Clean-Up**

Street sweeping has been done, C&W Nuite will be sweeping School Street one more time. Chris will be putting in the docks for Center Pond and Manhanock Pond.

**Item 9. Selectperson's Concerns:** Selectperson Cabot inquired about the cost of #2 fuel oil to heat the town hall building. From January 2022-current almost \$4,000 has been spent on fuel for the town hall, the annual budget for fuel is \$6,000. Discussed wanting to push forward on a new town office. The Select Board requested the dozer to be posted again for sale.


