**Item 9. Select Board Concerns:** Selectperson Gray inquired if there has been any communication regarding the Manhanock dam. No updates at this time.


**Adjourn.** Chair made a motion to adjourn at 4:15 pm, Selectperson Cabot 2<sup>nd</sup>, all in favor.
