- The activity is going on during the day, and during Pirate Rec practices and events.
- The Sangerville and Guilford Pirate Rec sheds have been broken into.
- They can't leave anything valuable in the sheds because of this. Trash has also been found down there too.
- Do NOT approach anyone under the influence of drugs!
- The local law enforcement will patrol the park more.
