**Item 3: Discussion and Update on the Fire Department Scot Packs** – Chair Peters made a motion to move the discussion to the floor, Selectperson Tracy, 2<sup>nd</sup>. Chair Peters and Matt Blockler spoke about the company the dept buys their scot packs and turn out gear from. They got a total for the scot packs and all the gear, which came out to \$36,940.00. Time frame to order it, and how do we pay for it? We have the money from the CD that was voted upon by the town at the Town Meeting in May. Chair Peters made a motion to instruct the fire chief to order the equipment, and we'll pay for it when it comes, Selectperson Tracy, 2<sup>nd</sup>. Matt Blockler, said the time frame is usually 30 to 60 days, but it may be sooner according to the company he spoke with. He knocked some money off the price for the dept. This is what the people voted for, and this is going to full fill that. Chair Peters made a motion to have Matt move forward with the gear, Selectperson Tracy, 2<sup>nd</sup>. All in favor.

**Item 4: Sign the Special Town Meeting Warrant -** Tabled. Misspelling on the warrant. Will need to be adjusted before the board can sign them. Extending the 2% discount will have to be voted on by the people at the Special Town Meeting.

**Item 5: Select board concerns: -** Chair Peters has had a lot of concern and compliments on the trimming job on the Burroughs Road. He just wanted to bring it to everyone's attention about the concerns. The contractor who was hired has finished the work and the bill is \$6600. He believes that one or two of the board and/or clerk should ride out to look at the job.

Selectperson Tracy has some concerns about Flanders Hill, and the spot by Peggy Cleaves where the tar is breaking up. Scott Reynolds had contacted Selectperson Tracy about it, because Jeff Libby had asked him to repair it, but he'd been unable to. He'd sent a couple of guys over to patch it until he got back. There are no cones out, but Matt Blockler offered to put up some cones from the Fire Dept. as it is a safety hazard until we can get the issue fixed. They will work on finding the answer to the issue.

Chair Peters had another concern he got from residents at the most recent Special Town Meeting. There was some concern about the prayer thing. We need to do a little research on that.

Adjourn: Chair Peters made a motion to adjourn the meeting at 5:13 pm, Selectperson Gould  $2^{nd}$ , all in favor. Adjourned.
